



Certificate of Limited Warranty



Parts and Labor Warranty

Pete's Auto & Truck Parts, Inc. warrants all purchases subject to the conditions and limitations below:

1. All parts are guaranteed to be free of defects for a period of 180 days from the date of purchase, which is the date on the invoice. If a customer purchases an extended warranty, a Gold Warranty is good for 365 days and a Platinum Warranty is good for 1,095 days from the date on the invoice. The labor warranty is paid out at up to \$75 per hour for the number of Mitchell Repairmate book hours, and up to \$100 in fluids, filters, seals, and gaskets, with a maximum payout of \$1,000.00. Once the labor warranty has been used, it cannot be used again and the customer must purchase an extended warranty on the replacement part if they wish to warrant it.
2. All parts may be returned for any reason in the first 30 days after purchase. After 30 days, Pete's Auto & Truck Parts, Inc. is not required to give a refund on the part. The customer is responsible for timely returns of parts. If Pete's Auto & Truck Parts, Inc. paid to ship goods to the customer, the customer will be refunded less the cost of shipping (both ways when applicable.)
3. Pete's Auto & Truck Parts, Inc. may, at its sole discretion, opt to replace the part(s), repair the part(s), or refund the purchase price.
4. According Michigan ruling on trade-ins and exchanges, Pete's Auto & Truck Parts, Inc. cannot (by state law) refund tax paid on a core charge.
5. Pete's Auto & Truck Parts, Inc. does not assume responsibility or liability for towing charges, rental vehicle use or charges, lay-up time, loss due to down time, labor, transportation, tools, or any other purchase required to install or uninstall a part.
6. All implied warranties are limited to the terms of this limited warranty. Consequential or incidental damages are not covered under this warranty.
7. Improper installation or failure to complete service bulletin items voids this warranty. Lack of manufacturer recommended maintenance also voids this warranty. The used part have purchased must be properly installed and maintained and you must have proof of installation and maintenance in order to fulfill the conditions of this warranty. Cooling systems must be flushed and have proper capacity. Engines must have new oil and filter installed upon installation and every 3,000 miles, transmissions must have new seals, filters, gaskets, fluids, upon installation. Front/Rear axles and carrier must have new fluid upon installation, etc.
8. Engines are warranted against cracked cylinder blocks or heads, bad camshafts or crankshafts, excessive smoking, and are in good working order unless otherwise stated. Accessory parts left on the engine for customer convenience are not warranted and not covered under this guarantee. They may need to be swapped for proper fitment.

To file a warranty claim, please contact Pete's Auto & Truck Parts, Inc. when the part is still installed in the vehicle and be prepared to provide diagnostic codes. All warranty claims must be authorized by Pete's Auto & Truck Parts, Inc. and will be processed within 15 days of authorization.
